Dr. Hollis Received the William K. Reilly Environmental Leadership Award for 2025

While attending the National Academy of Medicine's 2ndAnnual Climate and Health Summit, Dr. Adrienne Hollis received the William K. Reilly Environmental Leadership Award for 2025. The honor was shared with Dr. Gretchen Goldman, President at Union of Concerned Scientists. This is the 13th year of the awards program, held in honor of William K. Reilly, the former Administrator of the Environmental Protection Agency and a recognized leader in environmental and energy policy. The criteria for the award include a record of sustained leadership in environmental, energy, or sustainability issues: engaging and inspiring others in the field; experience in some combination of the public, private, and non-profit sectors; and encouraging or mentoring the next generation of leaders.

Policy & Advocacy

Engaging with decision-makers to support just, equitable, and community-driven solutions



Endorsement of H.R. 2995

This quarter, NWF endorsed H.R.2995 — a bill introduced by Representative Diane DeGette (D-CO) on the Protection from Cumulative Emissions and Underenforcement of Environmental Law Act of 2025. The bill aims to address environmental justice by requiring the EPA to develop and implement protocols for assessing cumulative impacts and health risks from environmental stressors like climate change and pollution. It also mandates the EPA to identify at least 100 EJ communities with environmental violations and to develop corrective action with state and local agencies. The EJ Policy team met with Rep. DeGette's staff to discuss a co-sponsor push and other ways to elevate EJ during this administration.

CECC March Round Table — Understanding the Current Administration's Environmental Justice Rollbacks

The Clean Economy Coalition of Color (CECC) is an alliance of some of the nation's most insightful Black, Latinx/e, Indigenous, Asian, and Pacific Islander leaders and advocates of color that are committed to amplifying ideas, recommendations, and solutions that uplift the priorities and economic interests of historically marginalized communities by guiding clean energy economy policies and implementation. The National Wildlife Federation's Environmental Justice, Health, and Community Resilience and Revitalization program hopes to uplift equitable policies to inform decision-makers, share resources to build capacity among CECC member organizations, unpack legislation and policies that impact our communities, and highlight leaders of color that are currently operating in the clean economy to share best practices and lessons learned.

In March, we hosted a timely session on Defending Environmental Justice in a Time of Deregulation and Rollbacks. The session brought together experts, advocates, and community leaders to discuss how the current administration's policies undermine environmental justice through regulatory rollbacks, funding cuts, and weakened enforcement.

Panelists explored the real-world impact on frontline and fenceline communities, strategies for resistance, and the role of advocacy in protecting hard-won EJ gains. Landscape Assessment is Complete!

This quarter, the results of the Landscape Assessment, which included 1:1 conversations, an internal audit of programmatic staff natural infrastructure work, an external "peer scan", and a literature review, were shared with NWF programmatic staff. As part of the NICER landscape assessment, we created an Airtable interface that includes the results, records, and data collected through the assessment. We shared the results by posting a <u>Field Notes post</u>, hosting a virtual "learning session," and by joining calls across different programmatic staff teams.

NICER Working Group

To improve collaboration and communication on NICER-related work, we are forming a cross-departmental NICER working group. Informed by the landscape assessment, this invite-only group will include staff from various programmatic teams, regional centers, and areas of expertise. In the future, the working group membership may expand to include affiliates and Directors of Conservation Partnerships (DCPs). While many at NWF contribute valuable work in this space, the group will include a representative set of staff whose roles, relationships, and expertise reflect the broader organization. The group will meet monthly to support the strategic development and implementation of the NICER.

Advancing the Implementation Plan

The EJ team has been hard at work on the programmatic development and a plan for the implementation and activation of the NICER. We've created a draft short, medium, and long-term plan for strategically scaling the NICER's initiatives. We are currently working on refining this plan with input from the NICER co-chairs and the NICER working group.

NICER & the Mississippi River Program Collaboration

The NICER continues to support the National Wildlife Federation's Mississippi River Program, with a particular focus on the Quad Cities region. A central initiative in this area is the protection of Milan Bottoms — a 500-acre, city-owned wetland complex vital to local biodiversity and climate resilience.

Prairie Rivers Network

For several years, NWF has partnered with its Illinois affiliate, Prairie Rivers Network (PRN), to promote community-driven, nature-based solutions and to help build long-term climate resilience grounded in the best available science within the Quad Cities. Together, NWF and PRN have joined a broader community effort to preserve Milan Bottoms, which plays a critical role in supporting diverse wildlife habitats and reducing flood risks amid growing climate challenges.

Special Shoutout!

A special shoutout goes to Nina Struss, PRN's River Health and Resiliency Organizer in the Quad Cities. As a community representative on the Mayor's Wetland Protection Task Force, Nina consistently uplifts local voices and perspectives. With support from NWF, she is helping to connect the Task Force with technical experts and critical resources, ensuring they have the scientific knowledge and tools necessary to protect and sustain this vital wetland ecosystem.

Action Alert! Support for the Empowering and Enforcing Environmental Justice Act

This quarter, our team <u>developed an action alert</u> in collaboration with the Digital team, urging NWF supporters to reach out to Congress and support the Empowering and Enforcing Environmental Justice Act. The bill would permanently codify the Environmental Justice office at the Department of Justice and provide funding to states and Tribes to enforce environmental regulations. As of June 3rd, there are over 11,000 letters sent.

Universal Dashboard

We are in the process of developing a Universal Dashboard to increase transparency surrounding our program and uplift the wide scope of projects and initiatives we undertake. The dashboard will cover all aspects of our program, including our strategic plan, communications, finances, policy, community engagements, and more.

Exploring Funding Opportunities

The NWF environmental justice program is actively reviewing and applying for funding. We had the opportunity to submit funding requests to two different funding sources:

- LOI to the New York Community Trust, National and International Environment Program.
- Proposal to the Burroughs Wellcome Foundation, Climate Change and Human Health Seed Grants.

Superfund Environmental Assessment Training

Becca Jimenez-Ward completed their first course in the Environmental Assessment Graduate Certificate program at North Carolina State University. Through the course, they learned the fundamentals of EPA Superfund environmental assessments (EA), including how to conduct an assessment and the key steps in the process. They hope to use this knowledge to better support communities navigating the Superfund process.

Strategic Planning & Program Alignment

Strategy pillar captains for the environmental justice pillars of the NWF Strategic plan met with their teams to reassess strategy goals and revise as necessary to best "meet this moment" in time. This included revising goals and action
